# **MINUTES**

#### III. MINUTES

- May 21, 2014 TAB meeting: Minutes approved 3, Don Nelson abstained as he was not present at the May meeting.
- April 21, 2014 CVMAC meeting: TAB reviewed.

#### IV. VIOLATION HEARINGS:

### 17224 Via Alamitos, San Lorenzo:

- Staff reported that 2 Modesto Ash trees had been topped. The trees were senescent, had been previously topped, and had large limb failures. Staff indicated that had the property owners applied for a permit to remove the trees the permit would have been approved.
- The Aldanas reported that the trees had dropped limbs in the past so they hired a contractor to trim the trees to make them safer. Mrs. Aldana indicated that when she spoke with County staff she did not realize she would need a permit.
- Dan G. and Walt F. felt that because of the topping cuts there was no choice but to remove and replace both trees. Discussion ensued.
- The Aldanas contended that the trees are green and are growing.
- TAB and staff explained why topping harms trees and that to allow the trees to stand would create a public safety hazard.
- Dan G. motioned to remove/replace the 2 trees, grind the stumps, and plant 2 replacement trees from approved list.

• Walt F. seconded the motion and amended it to eliminate any fines. Motion passed 3:1.

## 1763 Keller Ave, San Lorenzo:

- Staff reported that a Modesto Ash tree had been removed from this location without a permit. The tree was senescent, had been previously topped, was repeatedly pruned for line clearance, and showed previous failures. Staff indicated that had the property owners applied for a permit to remove the trees the permit would have been approved.
- Tom Stafford, Property Manager, reported that the property was a rental and the tenants and neighbors had complained for years that the tree was damaging their vehicles.
- Tom S. apologized for the removal and asked to be allowed to replace the tree and pay as small a fine as possible.
- Dan G. motioned to replace the removed tree with a County approved 24" boxed size tree and fine the owner \$100 for work without a permit. Walt F. seconded the motion and it was approved unanimously 4:0.
