Attached is an updated progress report on County Procurement. The information presented in this report is based on payments made to contractors. The summary chart of all payments up to \$500,000 for the period July 1, 2009 through December 31, 2023 is shown on Page A1 and includes:

- Total payments up to \$500,000 were \$2.05B
- \$1.22B was paid to local contractors which equals 59.52% of total dollars up to \$500,000
- \$1.00M was paid to MWBE/SLEB contractors which equals 48.87% of total dollars up to \$500,000

- Payments to MWBE/SLEB contractors by category were:

Construction:	\$97.8M which equals 37.74% of Construction dollars
Architecture & Engineering:	\$28.8M which equals 52.07% of Architecture & Engineering dollars
Professional Services:	\$394.9M which equals 59.33% of Professional Services dollars
Goods & Services:	\$479.6M which equals 44.88% of Goods & Services dollars

Also included in this report are all payments to contractors including amounts over \$500,000. This data is presented in the summary on Page A2 for the period July 1, 2009 through December 31, 2023 and includes:

- Total payments were \$4.60B
- \$2.46B was paid to local contractors which equals 53.44% of total dollars
- \$1.63B was paid to MWBE/SLEB contractors which equals 35.40% of total dollars

- Payments to MWBE/SLEB contractors by category were:

Construction:	\$264.3M which is 29.40% of Construction dollars
Architecture & Engineering:	\$35.6M which is 39.03% of Architecture & Engineering dollars
Professional Services:	\$543.0M which is 30.90% of Professional Services dollars
Goods & Services:	\$787.6M which is 42.39% of Goods & Services dollars

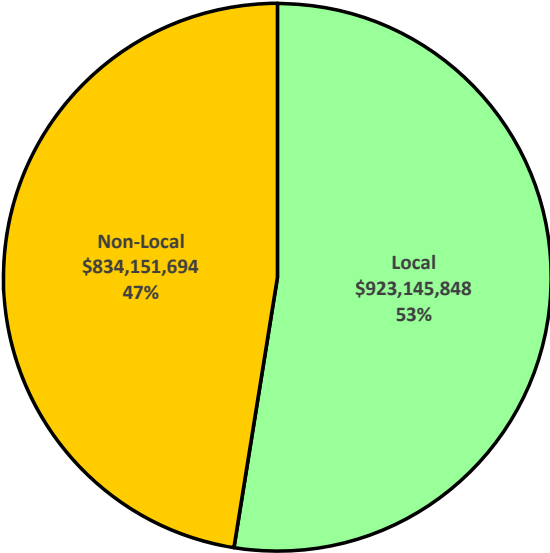


Local Utilization - All Architecture & Engineering Payments

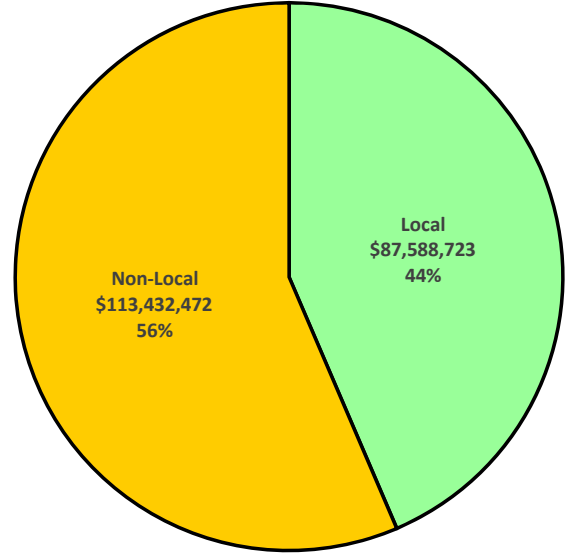

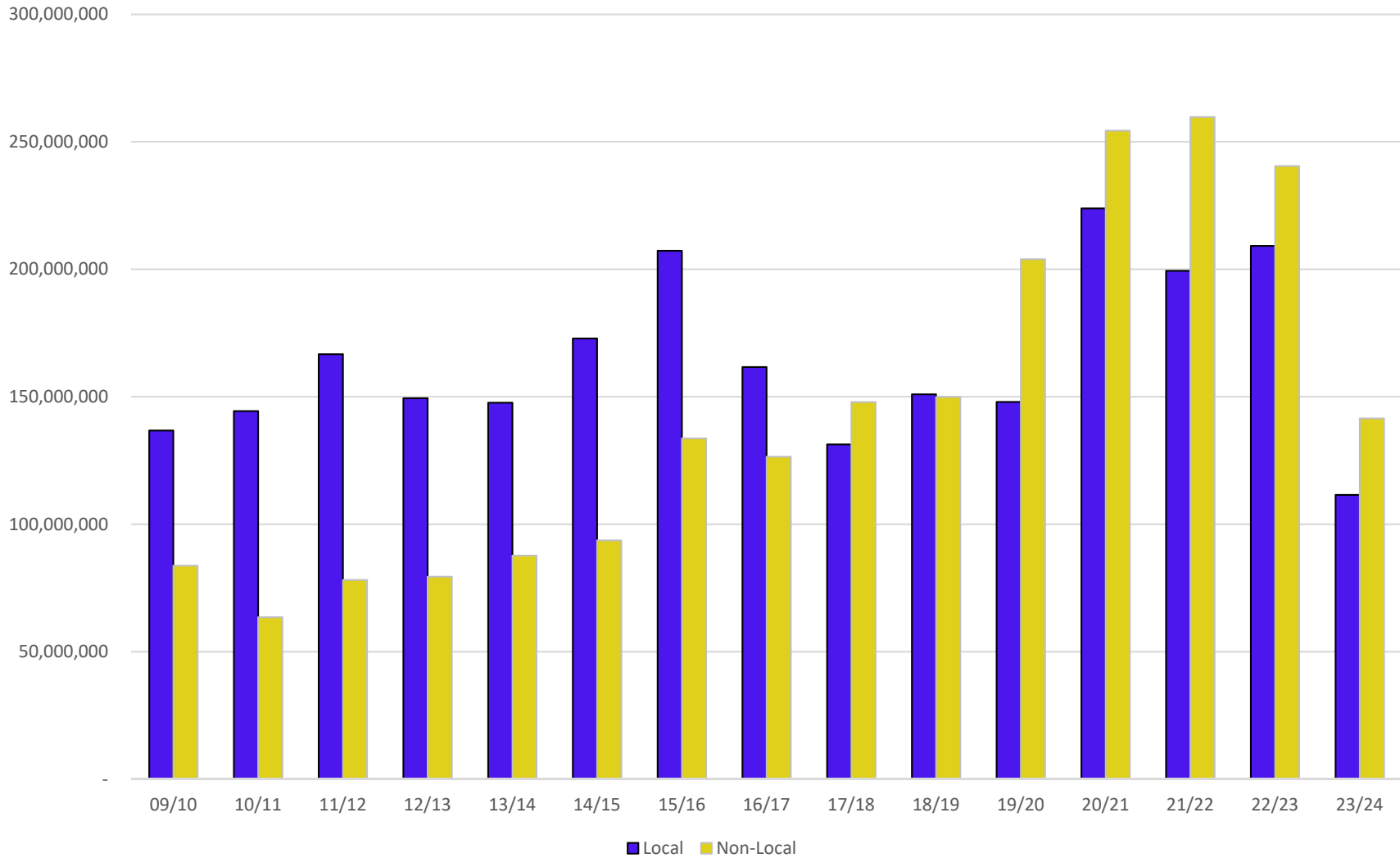
Overall Local Utilization by %

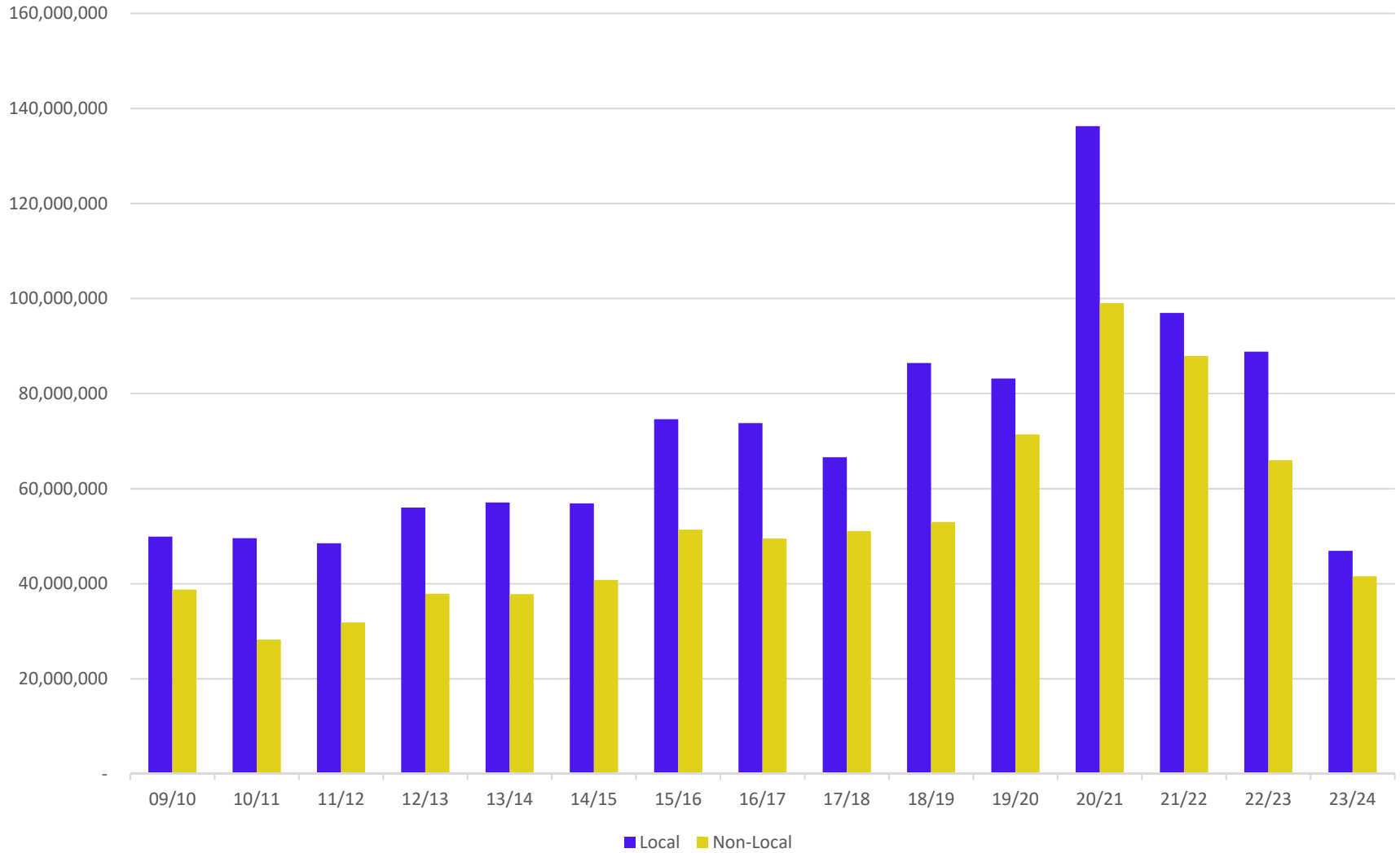
F1 - 7/1/09 - 12/31/23 - Overall Local Utilization by Percentage

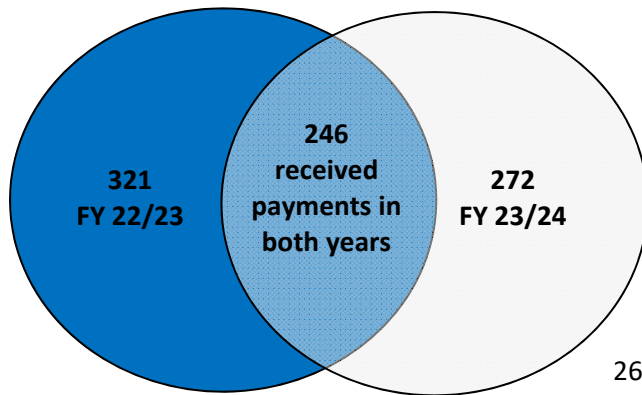
SLEB Breakdown by Ethnicity and Gender December 31, 2023



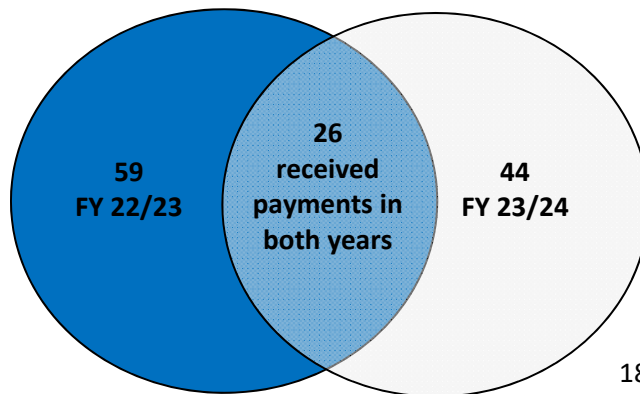

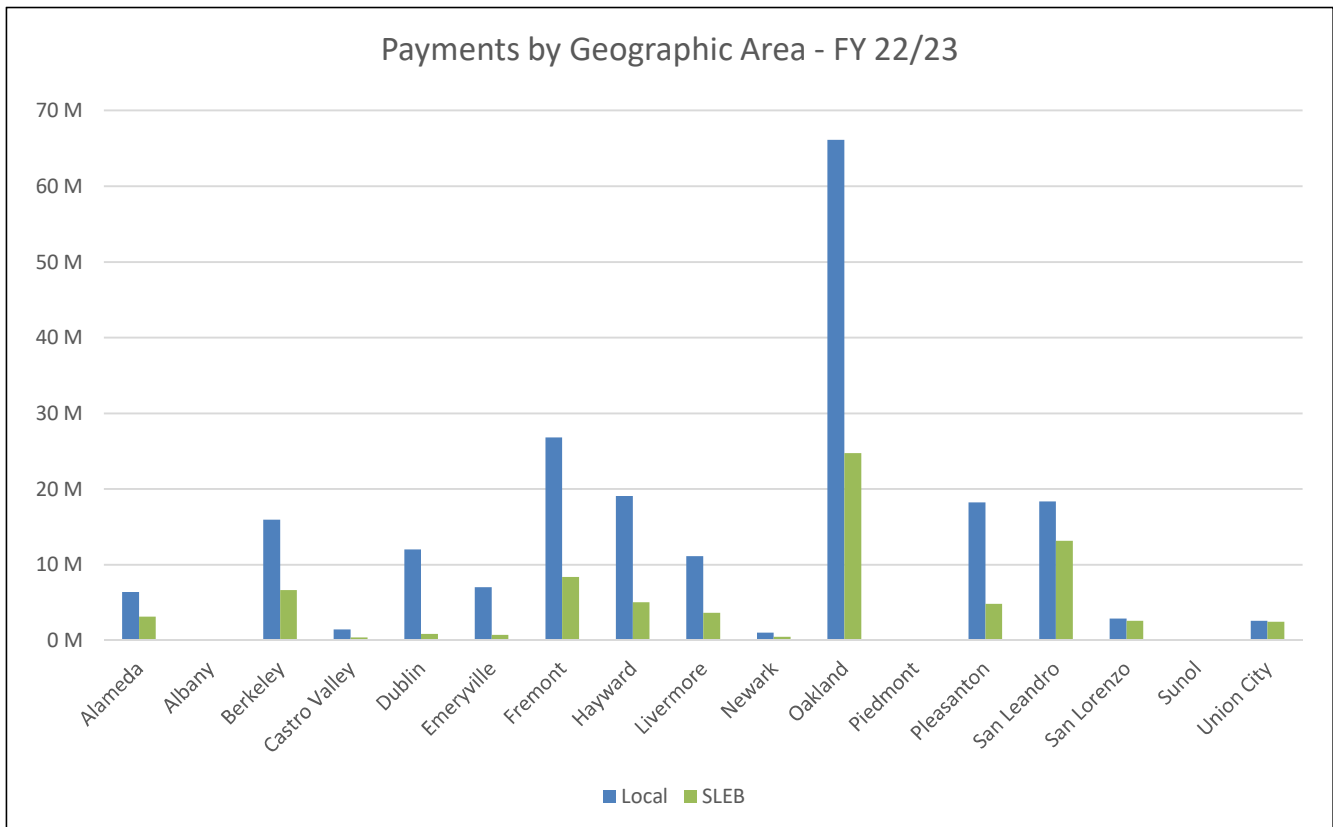
